With reference to your application dt. 24/8/94 for extension of ad hoc affiliation ~~and further to this office letter no. 111 dt. 11 granting ad hoc affiliation upto 10.4.96~~, I am to inform you that the Board has decided to accord ~~extension of~~ ad hoc affiliation to your school upto 31.3.98 for All India Secondary School Examination(s) of the Board subject to the following conditions:-


1. The School shall follow syllabi and courses as per scheme of studies prescribed by the Board for All India ~~Secondary~~ School Examination and changes made therein from time to time.
2. It shall acquire the required land as per Affiliation Bye-Laws in the name of the School/Society running the school, i.e., minimum one acre.
3. The School shall appoint only qualified and eligible staff.
4. The School shall help the Board in the smooth conduct of the Examination by placing the necessary accommodation, i.e., Halls, Rooms available in the School premises and furniture at its disposal for holding its Examinations free of charge, if required to do so.
5. The School shall spare sufficient teachers for invigilation purpose at the Examinations of the Board as may be required by the Board.
6. The School shall provide Laboratories, Library and other facilities as per norms of the Board.
7. The School shall pay to its staff, pay and allowances as par with the corresponding categories of the staff working in the Govt. Schools in the National Capital Territory of Delhi.
8. It shall function by a non-proprietary character Society/Trust

9. It shall constitute a School Management Committee as per Affiliation Bye-Laws/Scheme of Management approved by the Directorate of Education, Delhi.
 10. It shall execute a service contract with the staff who shall abide by the Service Rules as prescribed by the Directorate of Education, Delhi.
 11. It is required to obtain proper Health/Fire Safety/Drinking Water/Building Safety Certificate(s) from the competent authority(ies).
 12. A proper play-field facility be provided to the students and to obtain a certificate from the competent authority if adjacent play-ground is required for the purpose.
 13. The School shall create sufficient Reserve Fund as per the requirement of the Affiliation Bye-Laws/Rules of the Directorate of Education, Delhi in the joint names.
 14. The School shall not sponsor candidates for Board's Exams., of any other School/Branch which is not affiliated to the Board.
 15. To revise D.A. to be paid as per State Govt.
 16. To appoint regular Principal
- NOTE: It may please be noted that the Board has taken this decision only to avoid inconvenience to the students and their parents. In case of non-compliance of conditions specially that of land mentioned above, the Board will be constrained not to grant any further extension to the school even on ad hoc basis and the entire responsibility in this regard shall rest with the school authorities.




